### General terms and conditions donations

(Version 2018)

#### 1. Donation terms and conditions

- 1.1. These donation terms and conditions apply to any donation made to Dashamir Elezi – Fourcellina Project.
- 1.2. Dashamir Elezi – Fourcellina Project reserves the right to change the donation terms and conditions in the interim.

#### 2. Rights and obligations of Dashamir Elezi – Fourcellina Project
